#### **REPORTS**

- > Director
  - Schoolwide Integration of Computer Science Plan Alden Thorpe informed the board that the state of Utah has passed an initiative to get every school in the state to provide a robust computer science curriculum for every single student. He has been working on MWMA's computer science plan with other staff members of the school. He showed a powerpoint on the school's plan. The core concepts are:
    - ✓ Computing systems

The three things that they want to concentrate are make computer science standards easy, engaging, and authentic; connecting students with real world computer science; establish training and support for the teachers and offering middle school courses. They have been piloting this program through a grant this year in the third grade with robotics. Enabling students to dive deeper into the curriculum through computer science. We are looking into offering classes next year. We want to close the technology gap (divide). Some of the partnerships/connections the school has made are with Skill Struck (online coding platform), Imagine Learning (offered field trips to their offices, online q&a, mentoring, etc.) and Realms of Possibilities (science-based computer science). There was a discussion on connecting with free resources such as Code.org and Khan Academy and other companies that the school can connect with.

✓ Public Education Engagement and Exit Survey ADMIN Procedures — This will give the state data on why teachers are leaving the field. There are two surveys here. One is for all teachers to be given every other year and the other is given to any teacher that leaves the school whether it is on their own or if no agreement is offered for the next year. There was a discussion on whether or not the board will be able to review the data. Our teacher retention is pretty good for next year.

### > Academica West

• Financial Review – Cathie Hurst reviewed the finances through March 31st. The food service is doing very well. The state only allows 60 days operating expenses and if you have more than that then you have to submit a plan on how you are going to spend that. This is the first year Angie has to come up with a plan. Because the school bonded this year, the school is going to end up with a nice surplus. Overall everything looks like it should expect. Nelson asked about the federal resource's revenue being lower than expected. Cathie explained that the federal resources must be spent first and then we request reimbursements through Utah Grants. This year things have been slow to show up on Utah Grants. We rely on the state to approve the reimbursements before we can get the money. Cathie added that a lot of our federal programs that have deadlines but they have been extended to next school year. There was a discussion on the school trip refunds.
