- 2021-2022 Teacher & Student Success Act Plan Angie Johnson reviewed the 2021-2022 Teacher and Student Success Act Plan. It is very similar to the current year due to COVID. Angie reviewed the goals. We budget these funds for the following:
  - 5% of the TSSA fund will be used for professional learning activities.
  - 25% of the TSSA fund will be used for teacher salaries and bonuses.
  - 70% of the TSSA funds will be used for augmentation of existing programs.

The board wanted to know how much money the school was allocated. Last year the school was budgeted \$72,769. The preliminary numbers for next year \$86,240. Lois Bobo made a motion to approve the 2021-2022 Teacher & Student Success Act Plan. Andrew Marx seconded the motion. The votes were as follows:
