Figure 1. Temporarily Suspend In-Person Learning – Angie Johnson stated that the school hit their 30 students of positive COVID cases yesterday. Today we had a remote learning day. We will need to have the board vote for just tomorrow to suspend in-person learning and then we will take a remote learning day on Monday. This will be a five consecutive day break including the weekend days from in-person learning. We are hoping that our staffing will be back. The plan is to come back to in-person learning on Tuesday. There was a discussion on the three factors that the board bases their decision on and what is currently happening in the legislature for temporary suspending in-person learning. After a review of the facts and circumstances surrounding the prevalence of COVID-19 at Mountain West Montessori Academy, Corbin White made a motion to temporarily suspend in-person instruction at the school based on the following factors: 1. The school has reached the case threshold for a test-to-stay program; 2. The risks related to in-person instruction outweigh the value of in-person instruction; and 3. Mountain West Montessori Academy has measures in place to return students to in-person learning [Friday, January 28, 2022]. Nelson Altamirano seconded the motion.
